PA 4193 (PM/17/1183) – Lovell Partnerships Limited – Residential development for a maximum of 78 dwellings, extension to existing allotments, public open space, surface water attenuation pond and foul sewage pumping station (reserved matters relating to access, appearance, landscaping, layout and scale) – Brick Kiln Farm Rudham Stile Lane NR21 8JR.

At the D&M meeting on 14 August 2017 Councillors agreed to accept the application with no comments provided that the Clerk obtains a written assurance from the Planning Authority that the footpath along Rudham Stile Lane is still guaranteed. If not guaranteed the Councillors will strongly object to the application. In addition the Council believes that this application should contribute funding to road improvements at the junction of Thorpland Road, Greenway Lane and Holt Road. APPROVE
